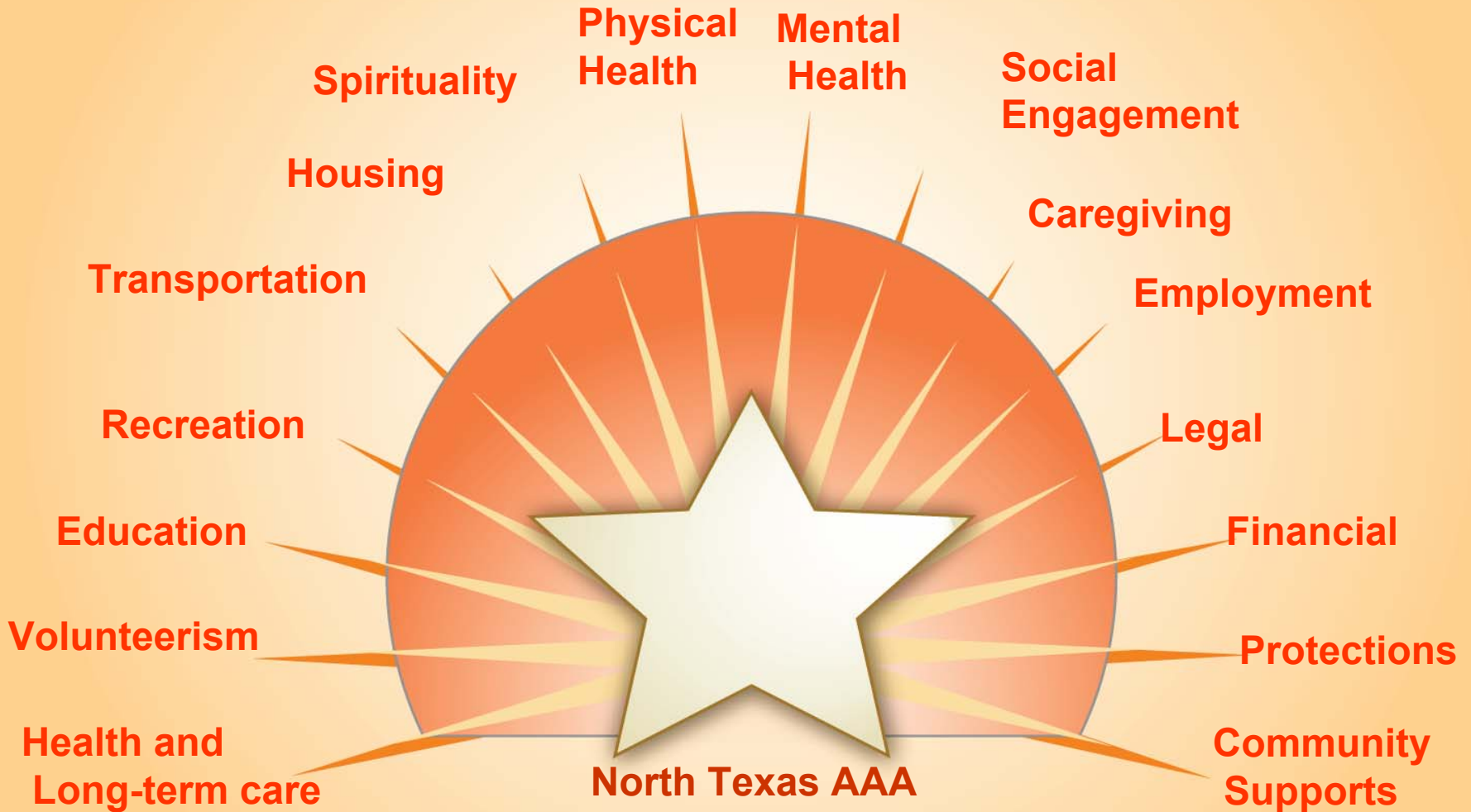

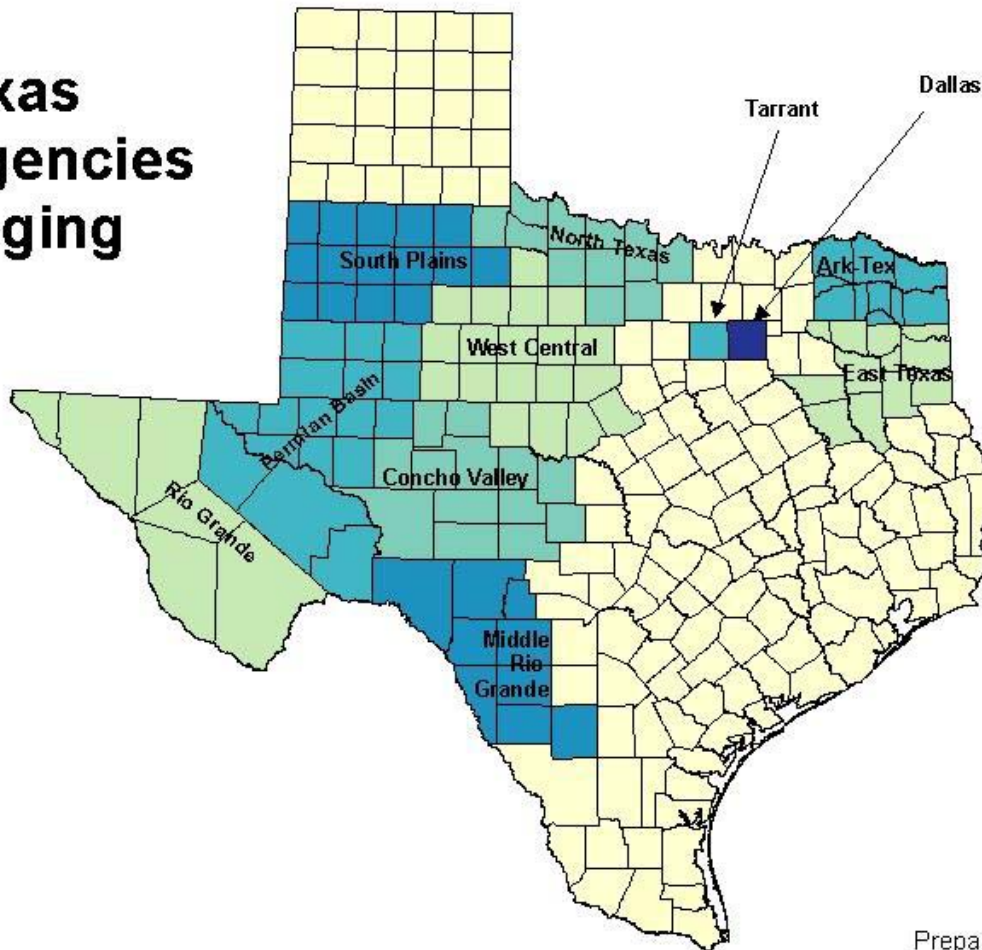

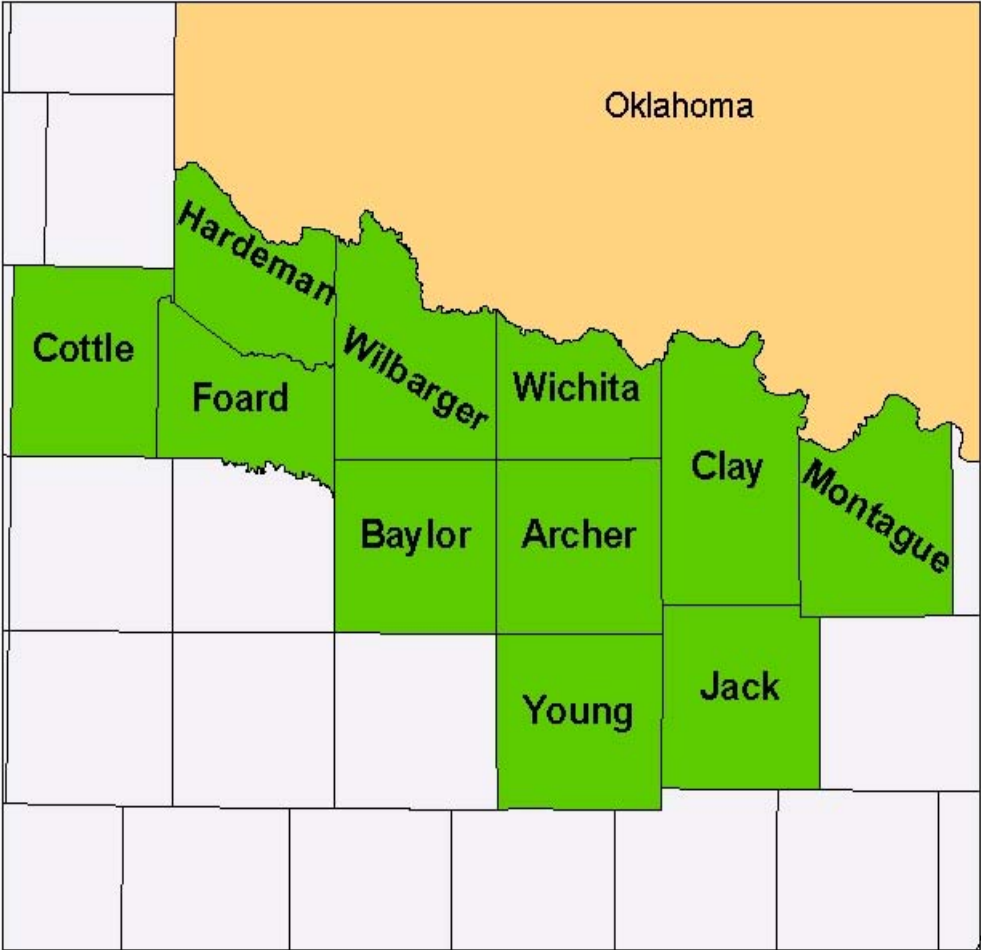

Socioeconomic Profile: Income

- Per capita income for North Texas AAA is \$16,582 vs. \$19,617 for Texas per capita income
 - Foard County has the lowest per capita income at \$14,799
 - Archer County has the highest per capita income at \$19,300
- Median household income in the North Texas AAA is \$30,525 vs. \$39,927 for Texas
 - Archer County has the highest median household income at 38,514
 - Baylor County has the lowest median household income at \$24,627

Socioeconomic Profile: Poverty

- 13.3% of North Texas AAA residents live below poverty vs. 15.4% of Texas residents
 - Cottle County has highest poverty rate: 18.4%
 - Archer County has lowest poverty rate: 9.0%
- 11.1% of North Texas AAA elderly live below poverty vs. 12.8% of Texas elderly
 - Foard County has highest rate of elderly living below poverty, 16.2%
 - Baylor County has the lowest rate of elderly living below poverty, 9.0%

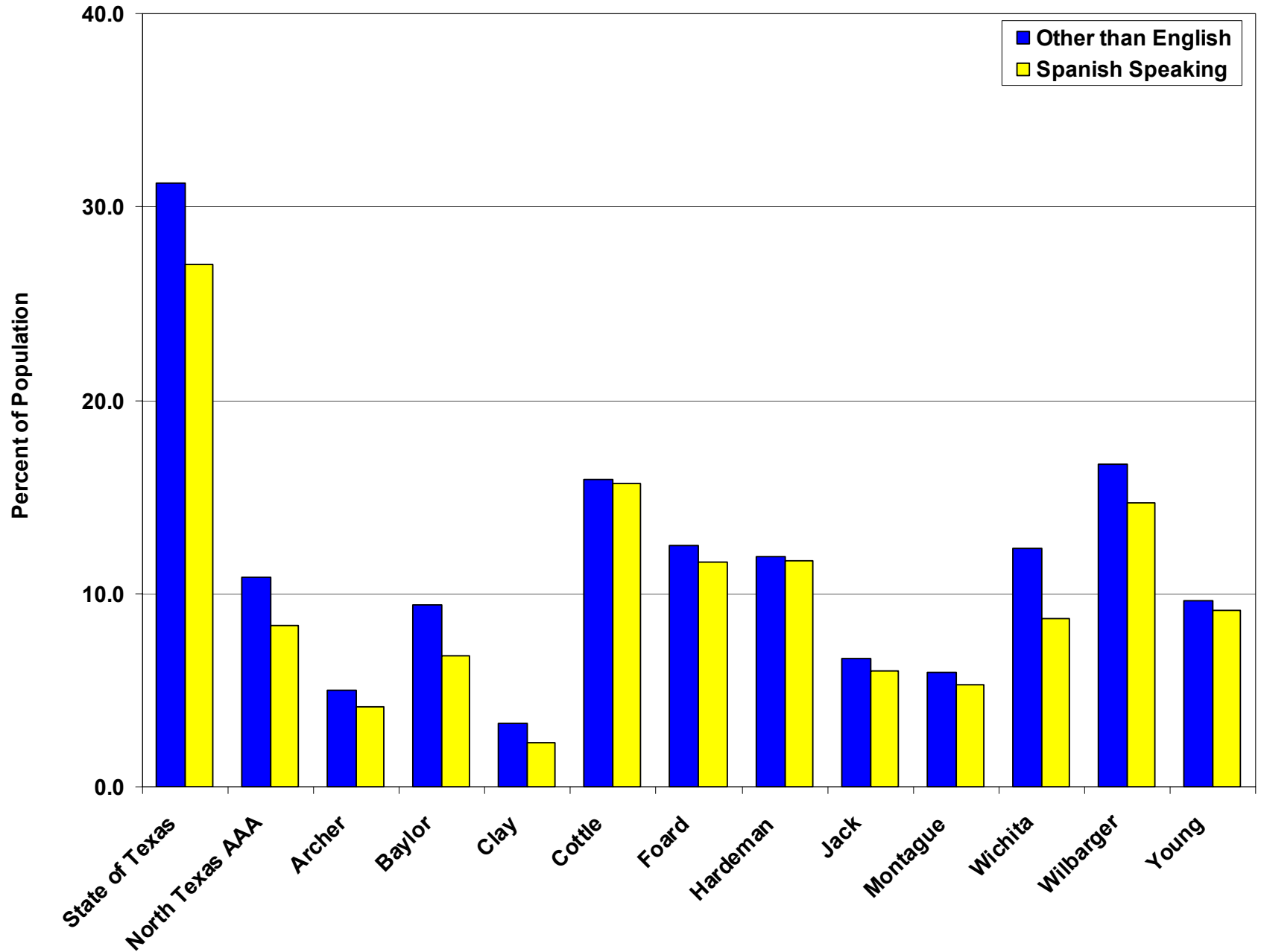
Elderly Household Characteristics

- 26.1% of North Texas AAA households include a member that is 65+ vs. 17.7% of Texas households
 - Cottle Co. has highest rate of households with someone 65 years old or older, 40.7%
 - Wichita Co. has the lowest rate of households with someone 65 years old or older, 22.6%
- 12.1% elderly live alone in North Texas AAA compared to 7.3% of Texas elderly
 - Cottle Co. has the highest rate of elderly living alone, 22.0%
 - Wichita Co. has the lowest rate of elderly living alone, 10.4%
- The percent of elderly with disabilities in North Texas AAA is 46.5% vs. 44.8% - the State rate
 - Baylor Co. elderly report the highest disability rate, 52.9%
 - Jack Co. elderly report the lowest disability rate, 42.8%

Language & Education Profile

- 10.8% of North Texas AAA residents speak a language other than English vs. 31.2 % of Texas residents
 - Wilbarger Co. has highest rate, 16.7%
 - Clay Co. has the lowest rate, 3.3%
- 8.4% of North Texas AAA residents speak Spanish vs. 27.0% of Texas residents
 - Cottle Co. has highest rate of Spanish speakers, 15.7%
 - Clay Co. has the lowest rate, 2.3%
- High School completion or equivalency in North Texas AAA is 77.4% vs. 75.7% for Texas
 - Archer Co. has highest HS completion rate, 81.1%
 - Cottle Co. has lowest rate, 66.1%

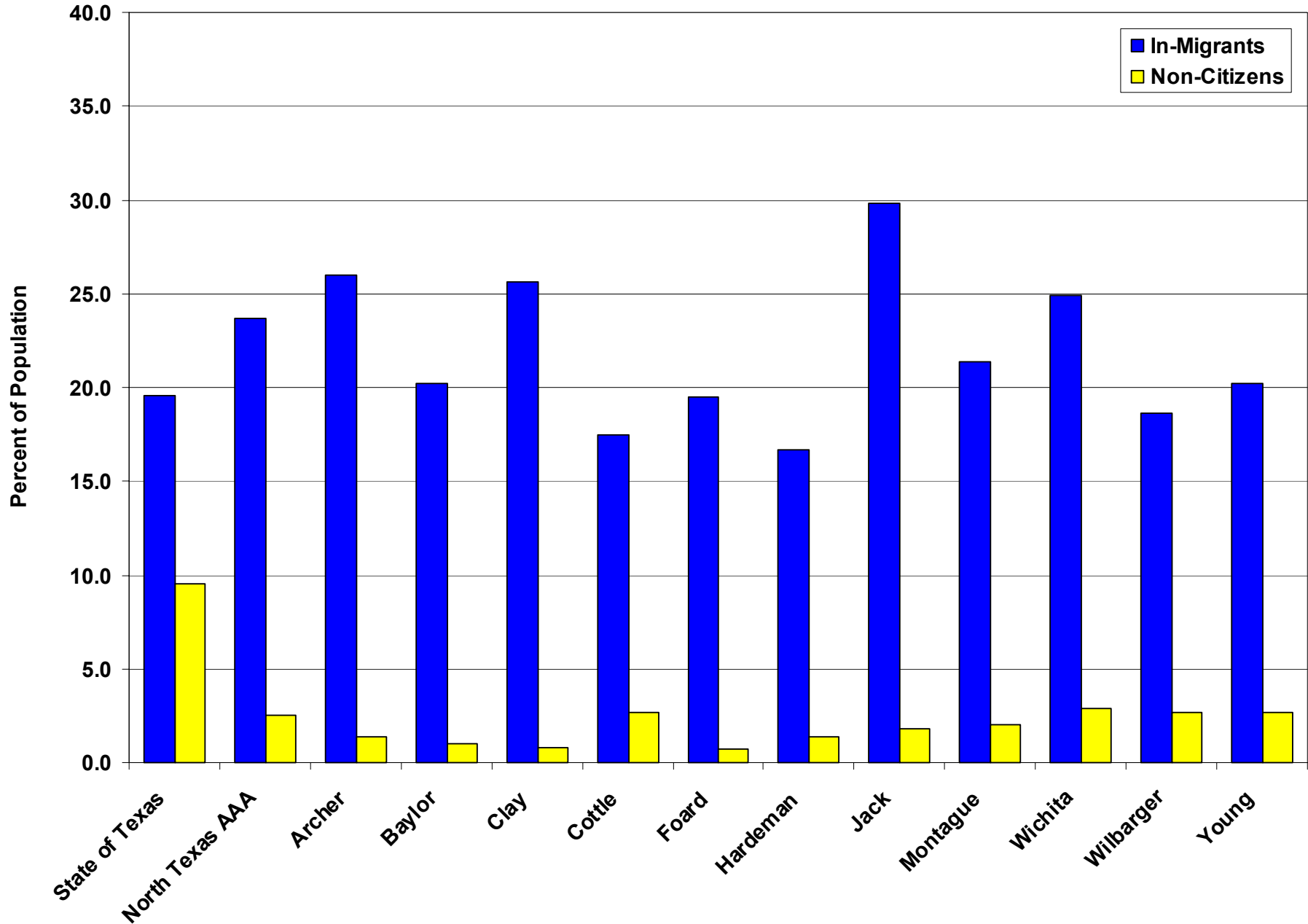
Figure 1: State and North Texas AAA Language Diversity in 2000



Residency Status of Population

- In-migration rate for the North Texas AAA is 23.7% vs. 19.6% for Texas
 - Jack Co. has highest in-migration rate, 29.8%
 - Hardeman Co. has lowest in-migration rate, 16.7%
- Non-citizen rate for North Texas AAA residents is 2.5% vs. 9.5% for Texas
 - Wichita Co. has the highest rate, 2.9%
 - Foard Co. has the lowest rate, 0.7%

Ethnic Diversity

- North Texas AAA has a higher percent of non-Hispanic White residents than Texas, 79.2% vs. 53.1%
 - Clay Co. has highest rate of non-Hispanic Whites, 94.8%
 - Wilbarger Co. has lowest rate of non-Hispanic Whites, 69.2%
- 11.3% of North Texas AAA residents are Hispanic vs. 32% of Texas residents
 - Wilbarger Co. has highest rate of Hispanics, 20.5%
 - Clay Co. has lowest rate of Hispanics, 3.7%
- 7.4% of North Texas residents are African American vs. 11.6% of Texas residents
 - Wichita Co. has highest rate of African Americans, 10.6%
 - Archer and Montague Co. have the lowest rate of African Americans, 0.2%
- Figures 3a, 3b, 3c illustrate the projected decrease in non-Hispanic Whites and the corresponding increase in Hispanics

Figure 3a. State and North Texas AAA Ethnic Diversity in 2000

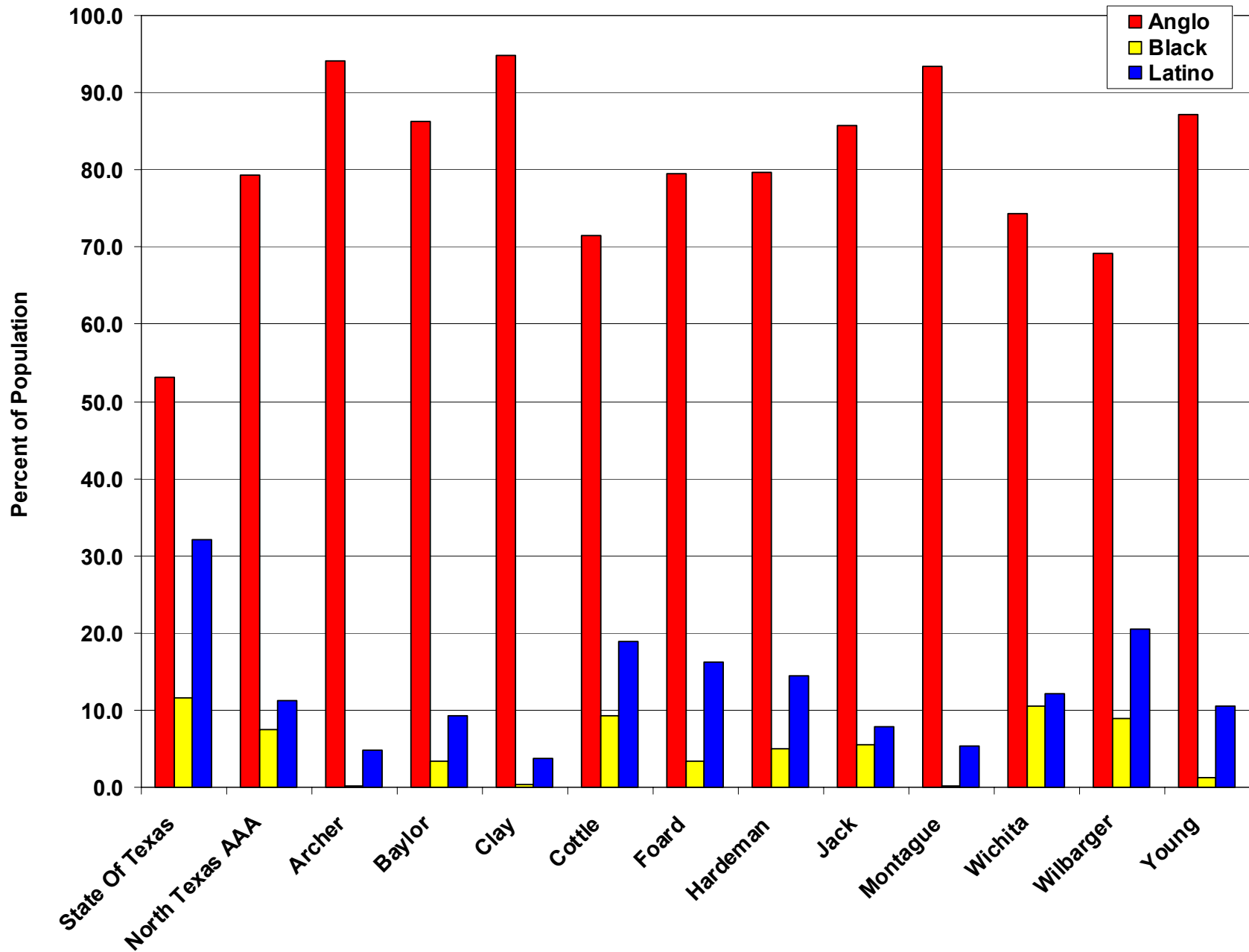
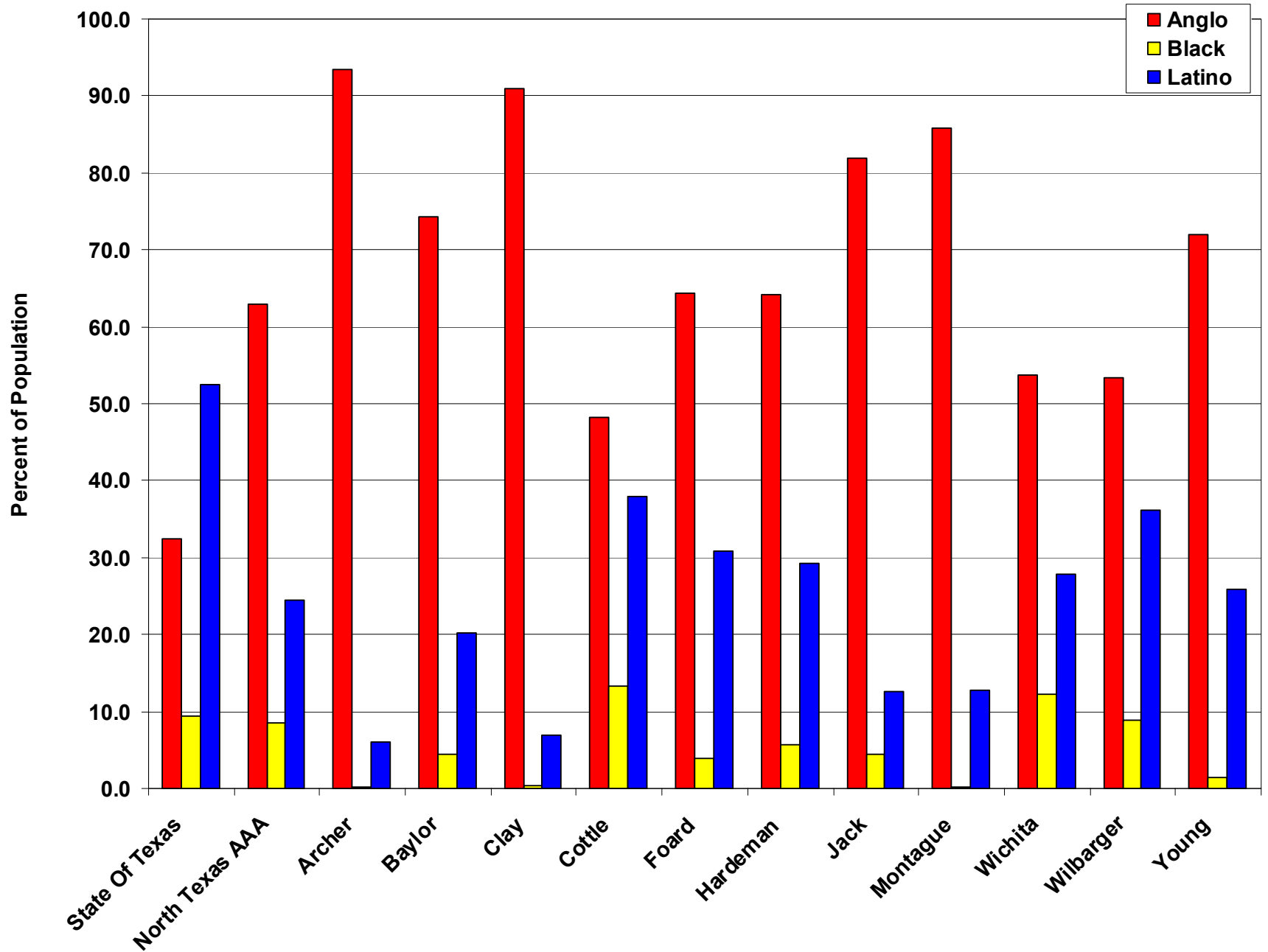


Figure 3c. State and North Texas AAA Ethnic Diversity in 2040

- Figures 7a, 7b, 7c (in your packet) illustrate the current and projected proportion of the population that will be elderly for each ethnic group by 2040

Figure 4. Current and Projected Percent of Population that will be Elderly

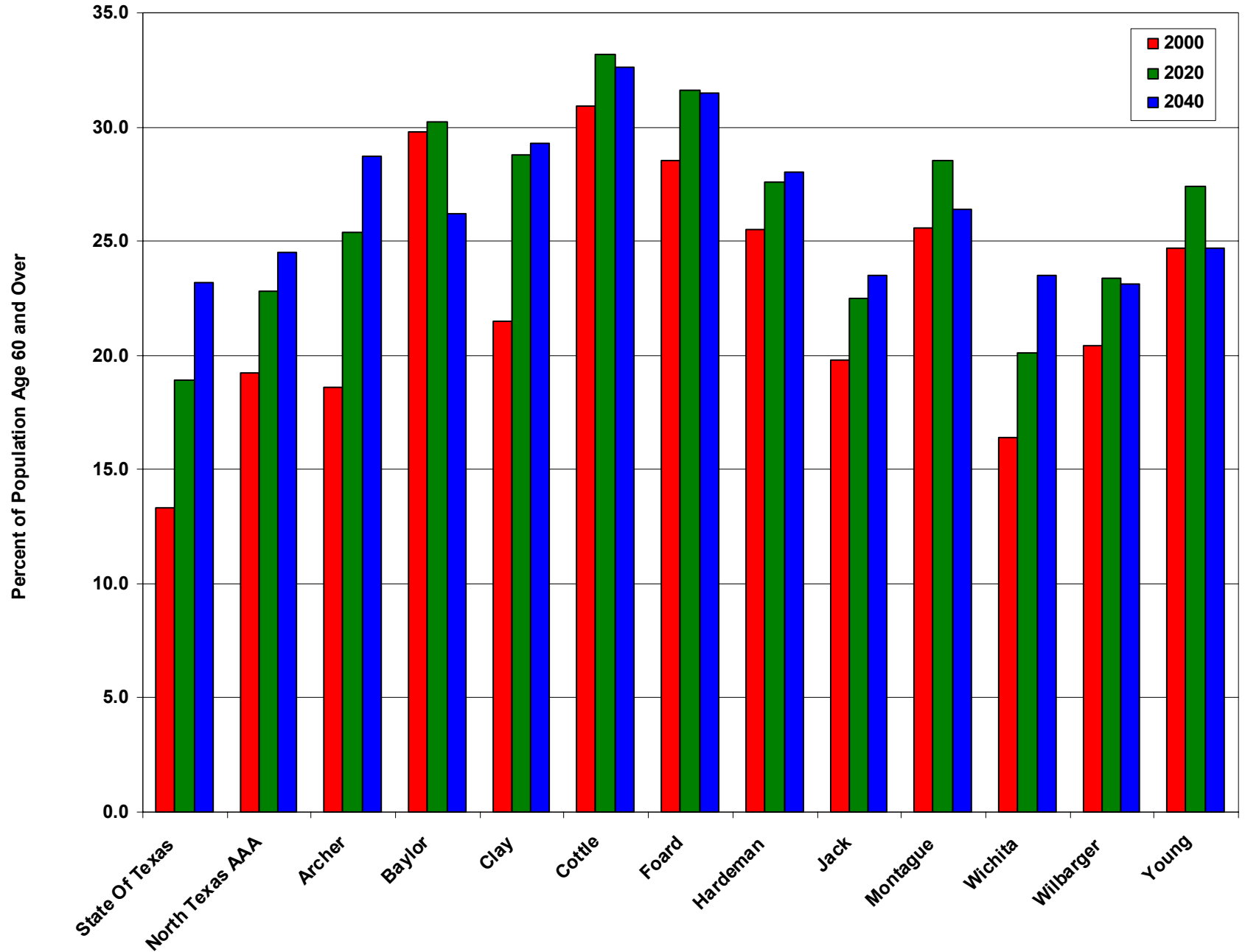
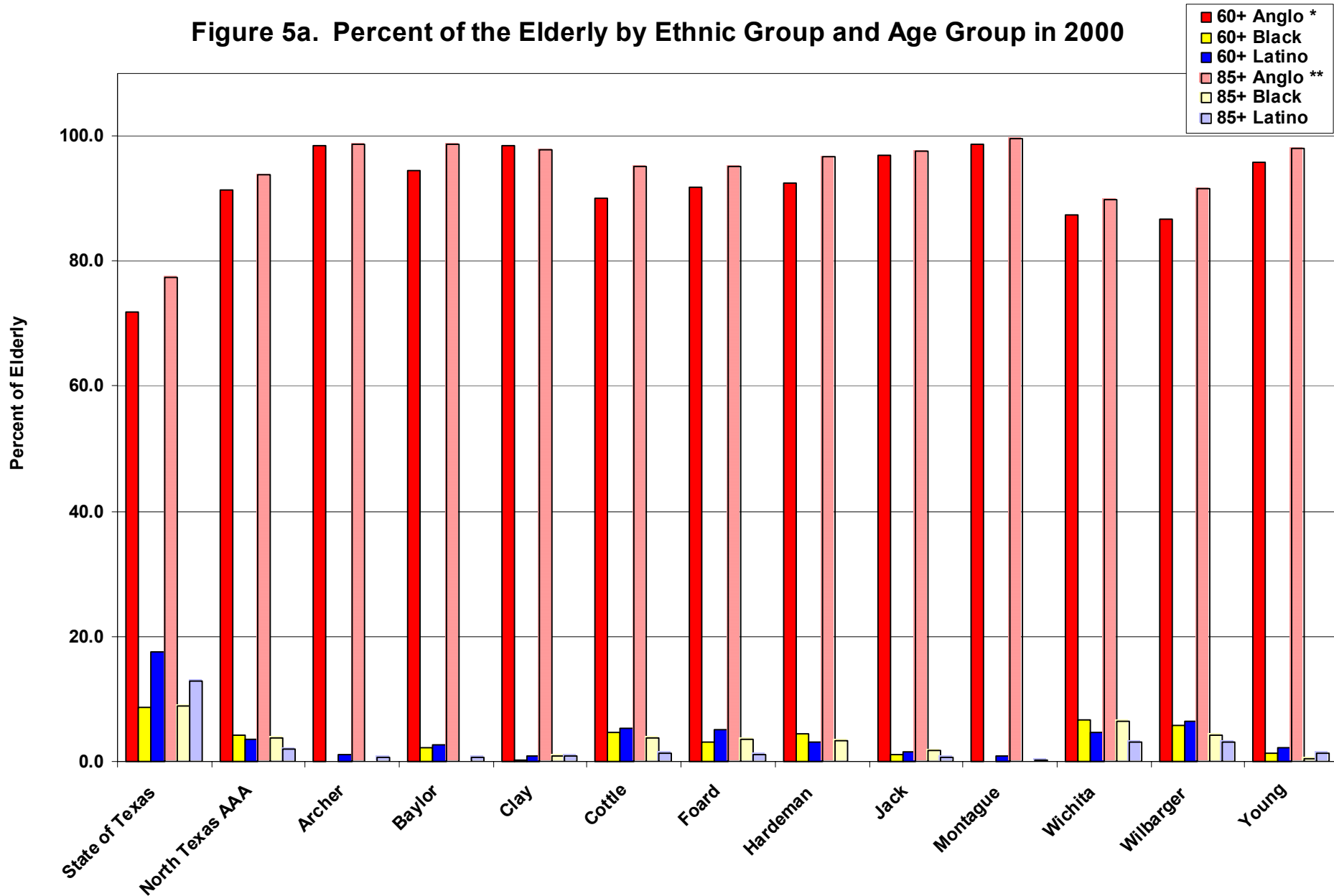


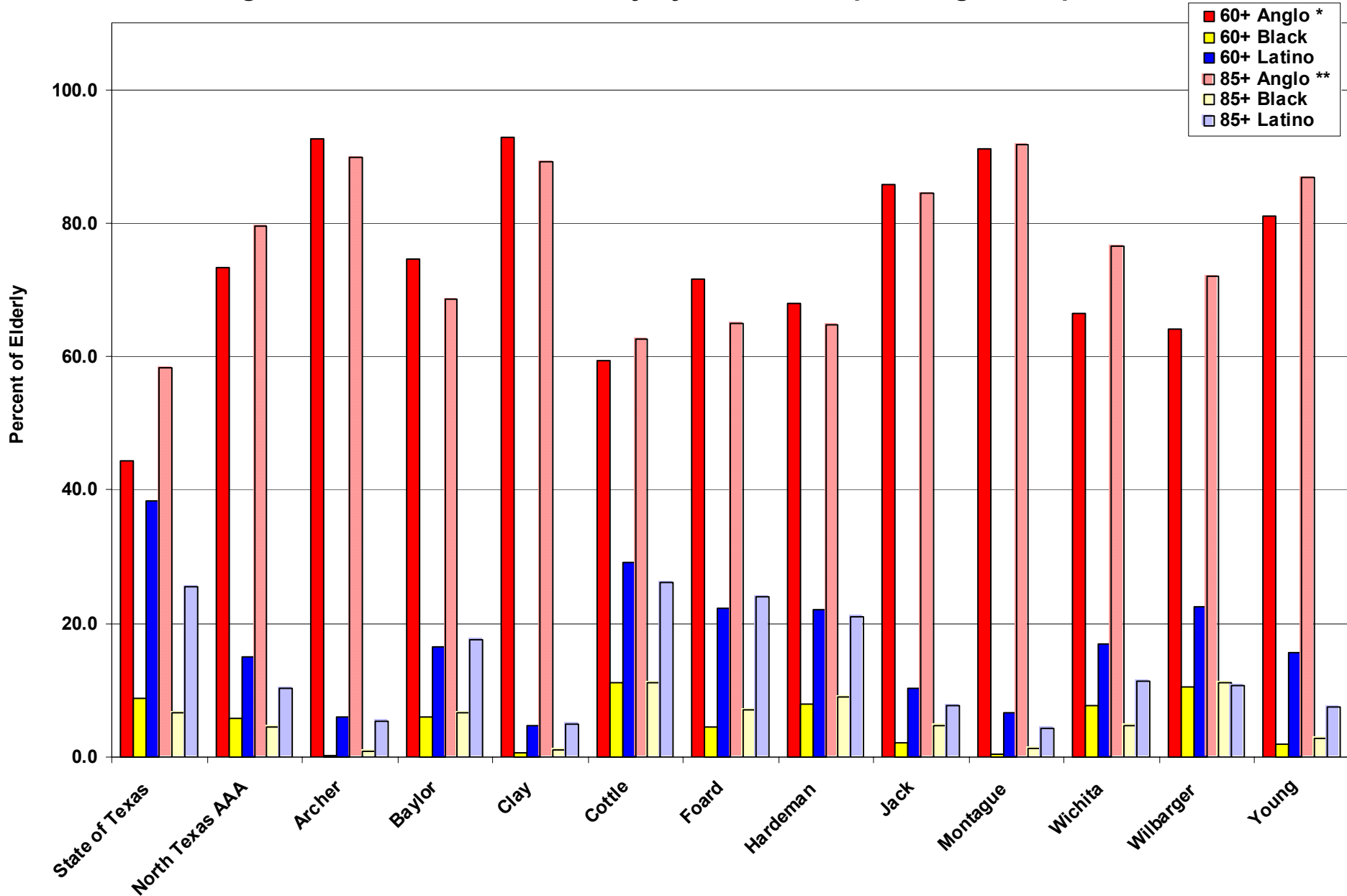
Figure 5a. Percent of the Elderly by Ethnic Group and Age Group in 2000



* Example: Of the total elderly (60+) in North Texas AAA in 2000, 91.3% are non-Hispanic White. $(\text{white elderly} / \text{total elderly}) * 100 = 91.3\%$

** Example: Of all residents over 85 years in North Texas AAA in 2000, 93.8% are non-Hispanic White. $(\text{white 85+} / \text{total 85+}) * 100 = 93.8\%$

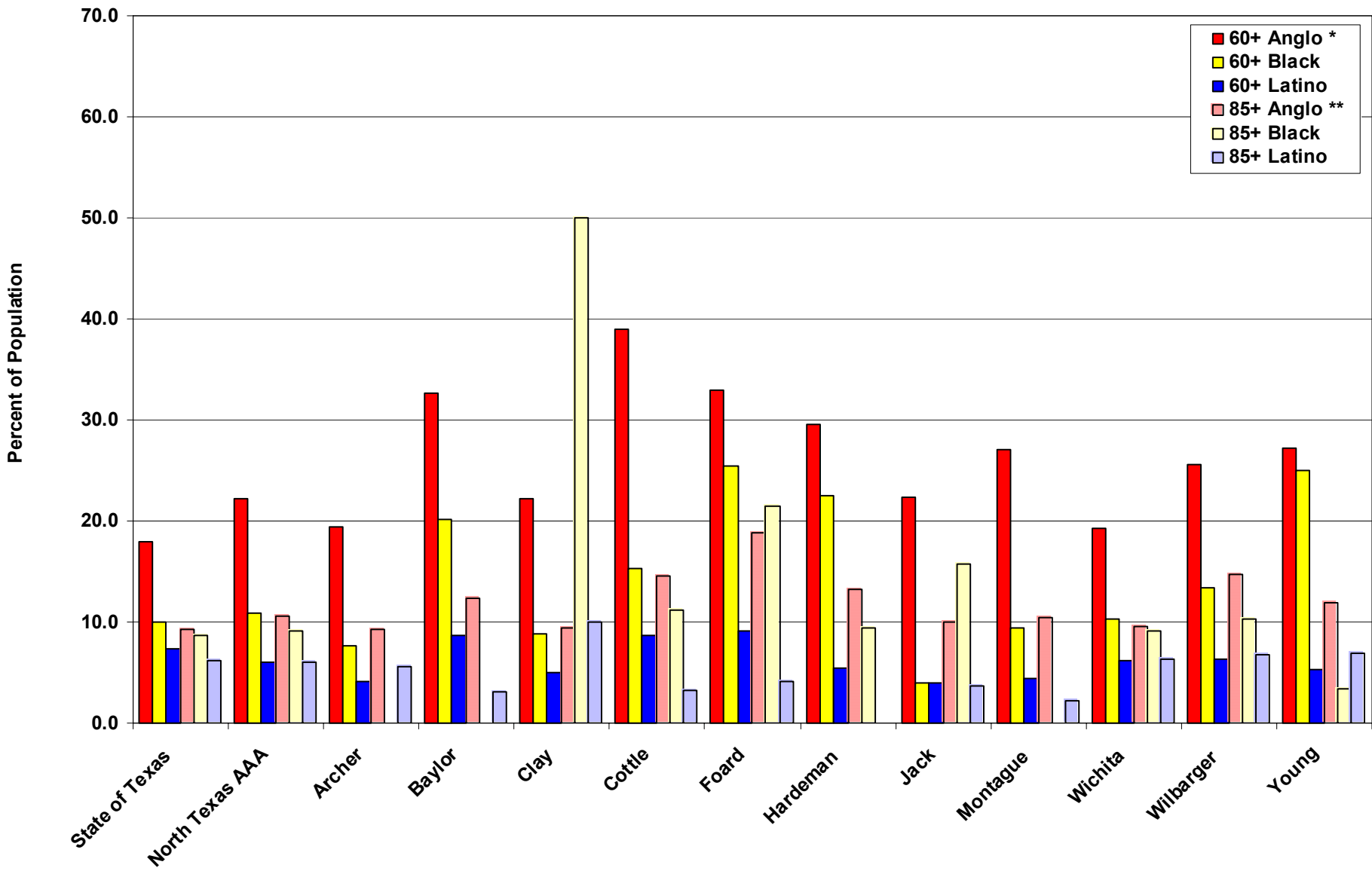
Figure 5c. Percent of the Elderly by Ethnic Group and Age Group in 2040



* Example: Of the total elderly (60+) in North Texas AAA in 2040, 73.4% are non-Hispanic White. $(\text{white elderly} / \text{total elderly}) * 100 = 73.4\%$

** Example: Of all residents over 85 years in North Texas AAA in 2040, 79.5% are non-Hispanic White. $(\text{white 85+} / \text{total 85+}) * 100 = 79.5\%$

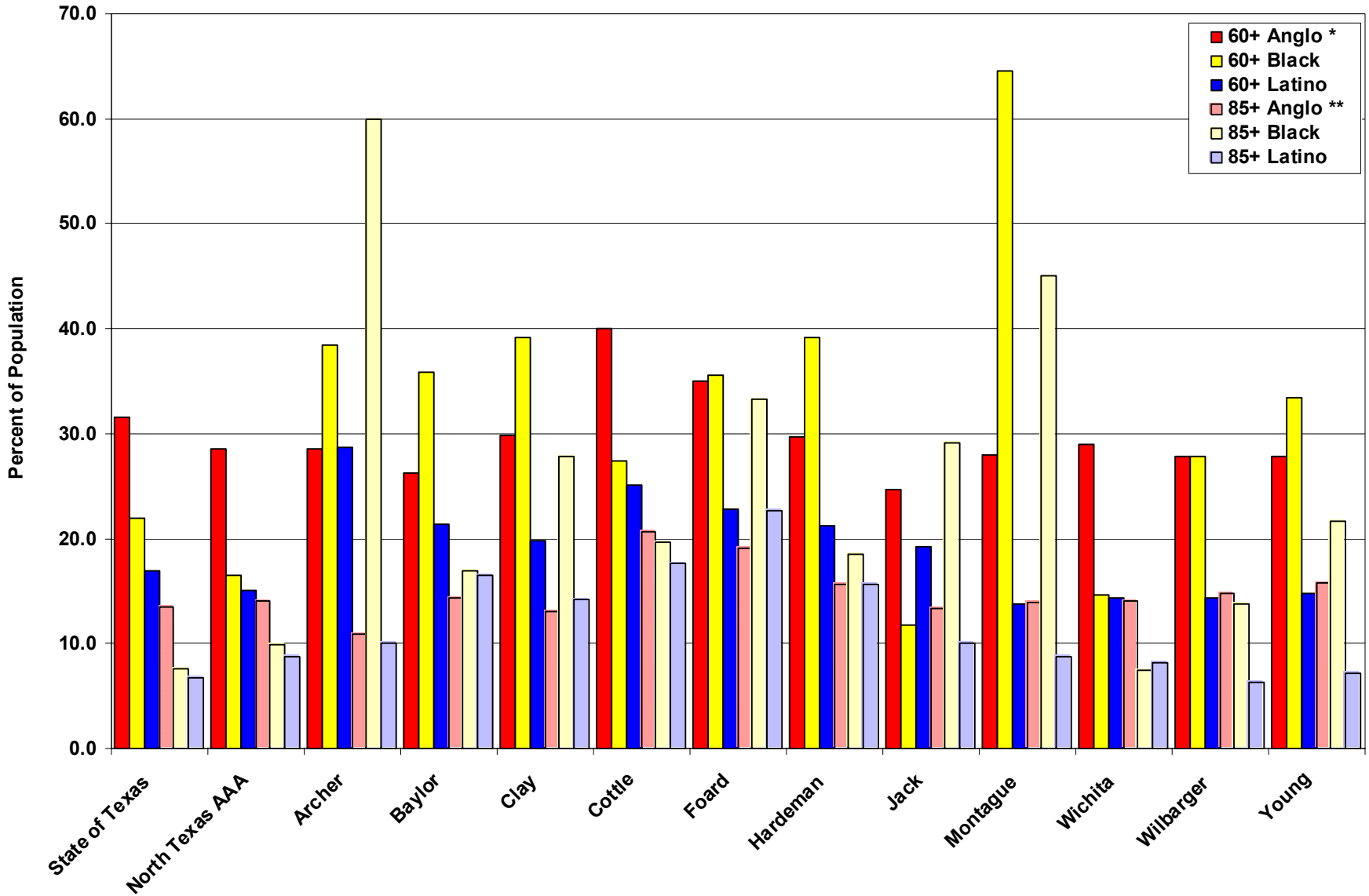
Figure 5d. Percent of the Population within each Ethnic Group that are 60+ and Percent of those 60+ that are 85 and Older in 2000



* Example: Of the total non-Hispanic Whites living in North Texas AAA in 2000, 22.2% are over the age of 60 years.

** Example: Of the total non-Hispanic Whites 60+ in North Texas AAA in 2000, 10.6% are 85+. (white 85+ / white 60+)*100 = 10.6%.

Figure 5f. Projected Percent of the Population within each Ethnic Group that are 60+ and Percent of those 60+ that are 85 and Older in 2040



* Example: Of the total non-Hispanic Whites living in North Texas AAA in 2040, 28.6% are over the age of 60 years.

** Example: Of the total non-Hispanic Whites 60+ in North Texas AAA in 2040, 14.0% are 85+. (white 85+ / white 60+)*100 = 14.0%.

Figure 6a. Differences in Sex Distribution Among the Elderly Population in 2000

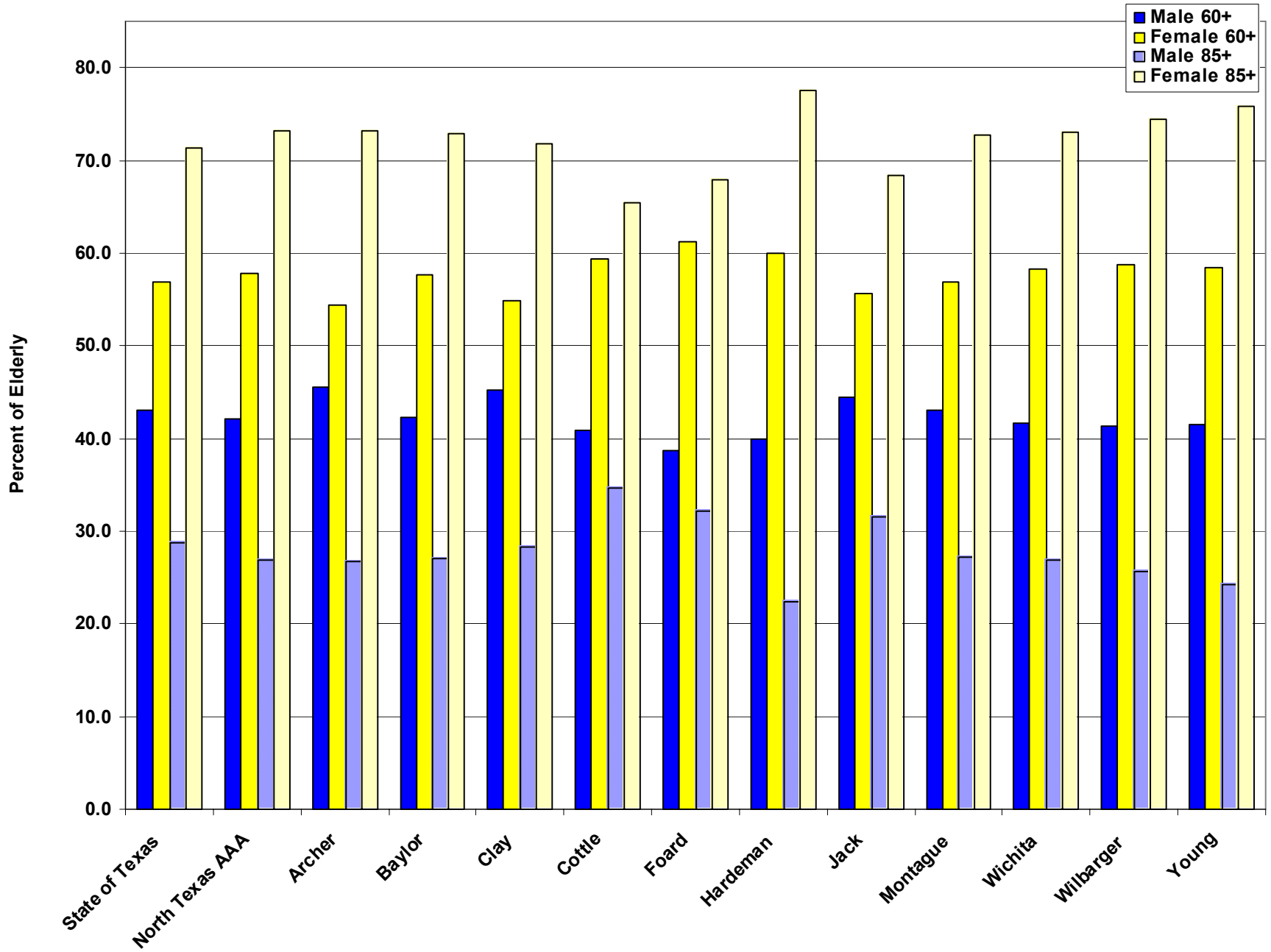
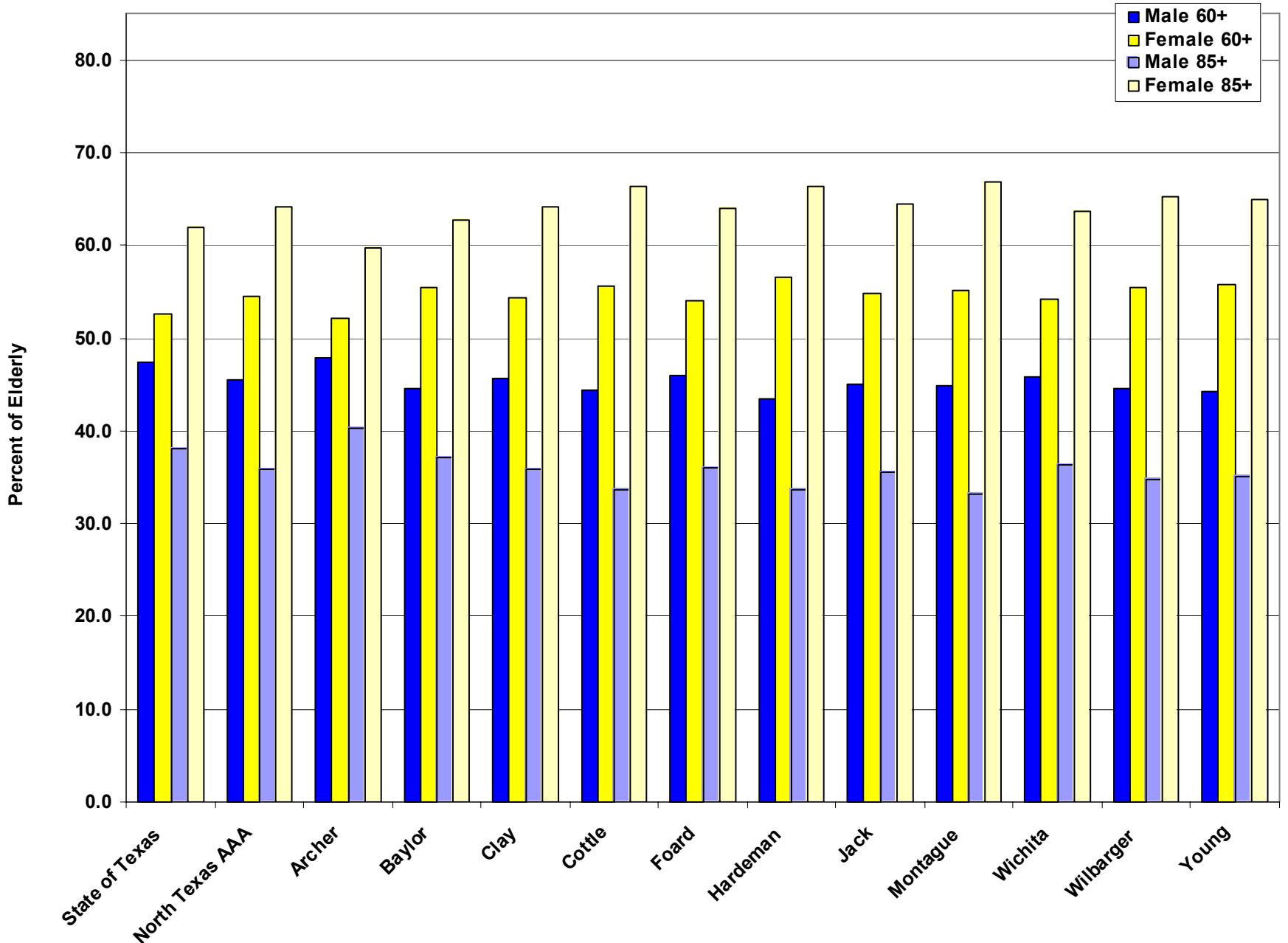


Figure 6c. Differences in Sex Distribution Among the Elderly Population in 2040
